He became one of our early pioneer settlers when at the age of three his parents moved to Dayton township and settled on the farm where he spent his entire life. He was united in marriage October 3, 1872, to Miss Cynthia Barry and to this union was born one child, Mrs. Sylvia Smart of Richland Center. Mrs. Hofius preceded her husband in death having passed away January 4, 1932. Mr. Hofius had nine brothers and sisters all of whom preceded him in death except Mrs. Ida Langhoff of Mason City, Iowa, and Mrs. Effie Kite of Byrds Creek. His death came without warning some time after retiring Wednesday night. Mr. Hofius would have been 86 years of age had he lived until December 3rd. He was born in the state of Pennsylvania and came to the town of Dayton and to the farm on which he died in 1857 and lived continuously on the same place for 83 years. He became a successful farmer and grew in esteem among his neighbors until he held many positions of trust. He represented his township on the county board for 21 years and was a member of the school board of his district for 40 years. Among the incidents of interest which Mr. Hofius was able to relate was that he served as juror at the first court case conducted in the present court house in Richland Center.

He is survived by one daughter Mrs. Sylvia Smart who resides on the home farm, and by two grandsons Joe Smart who lives with his mother, and George Hoflus who resides at Excelsior.
